Financials Continued

Nancy reports the Betty L CD was reinvested as the board had approved. It should yield about \$4000 over the term.

Nancy had issues with the closest Finance Center, but went to another and had a better experience at another. The Finance Center asks for a board resolution approving the new officers on June 1 Sherry, Charlotte, Peggy, and Richard to have the authorization to do financial operations at the bank.

Tom mentions the by-laws change and wonders if it is appropriate for us to pursue it since we were able to fill the slate this year and wonders about its impact in relation to future size of the church – would it be limiting if we have growth? Tom mentions that the specific bylaw proposed did not include quorum, which is a different by-law, so it would remain at 5 with a 7 member board. It was generally agreed that would create a problem.
