Dear Oaklandon Unitarian Universalist Church,

Thank you for your gift of \$611.34 on September 21st, 2023 to the American Civil Liberties Union of Indiana Foundation. We are grateful for the generous commitment of Hoosiers such as you to protecting and advancing the rights of all. Thank you for your support.

Your gift comes at an important time. While the abortion ban has gone into effect, the fight is not over—we still have a role to play to protect the health and lives of Hoosier women, and to fight back against a type of law the vast majority of Hoosiers oppose. Most notably, we continue to pursue our lawsuit enjoining the abortion ban on behalf of Hoosiers whose religious beliefs necessitate access to abortion care. We are also pursuing emergency litigation to determine if the near-total abortion ban's insufficient protections for the health and well-being of the mother definitively violate the State Constitution. During August, we filed a suit on behalf of an Indiana citizen journalist whose First Amendment rights are being violated by the state's prohibition on filming within 25 yards of police activity. This prohibition is meant to suppress the public's ability to monitor law enforcement actions, marking the worst attack on the Freedom of Speech in Indiana since last year's legislative attempt to criminalize protesting.


Here are some other important efforts we are undertaking right now, thanks to your support:

- The vast majority of Hoosiers—nearly nine out of 10 people—are against an abortion ban like the one passed last year, yet most Hoosiers believe they are in the minority by supporting abortion access. We continue working to combat harmful misinformation about abortion, so that everyone can make a safe and informed choice. Join this effort at www.LetsTalkAboutAbortionIndiana.com
- With critical nationwide elections just over a year away, and municipal elections occurring this fall, we are investing in strengthening and expanding our voting rights work. We will run a strategic, statewide *Yes! You Can Vote!* media campaign to inform traditionally disenfranchised communities about their right to vote in Indiana. We stand ready to block any attempts to keep Hoosiers from exercising their democratic rights.
- We have filed multiple lawsuits to block the "Slate of Hate" from going into effect—multiple anti-LGBTQ+ laws that would, among other things, ban affirming healthcare for trans youth, force the outing of LGBTQ+ school children, and allow any individual to censor books and educational material.

We know that attacks on our fundamental liberties will always exist, but we are able to fight these and other battles because of generous Hoosiers such as you.
